**CJA Appellate Panel:** To be considered for membership on the CJA Appellate Panel for the United States Court of Appeals for the Fourth Circuit, an attorney must be a member of the bar of the Fourth Circuit in good standing and have demonstrated experience in, and knowledge of, federal criminal law and appellate procedure and the Sentencing Guidelines. Attorneys must also maintain a physical office within the circuit since the Plan's appointment provisions generally call for appointment of counsel from the district in which the case arose.

CJA Appellate Panel members are appointed in rotating order in direct criminal appeals in which trial counsel has been granted leave to withdraw. Notification of potential case assignments is sent through CJA eVoucher. All appointments are subject to maximum case compensation provisions.

# **Application Period:** The CJA Panel application period runs from June 1 to September 1 each year.
